### Better Prices

We've lowered rates at many ages and at all previously offered term lengths. Our competitive position is significantly improved even though we've increased policy fees to \$68 on face amounts under \$1 million and to \$98 at \$1 million and above. The low band policy fee at \$100,000-199,999 remains fully commissionable. Sample annual premiums:

### Broader Bands

We've added a \$500,000 - \$999,999 rate band, which means even more premium savings for your clients in this sweet spot. For example:

### Other Changes

In order to remain as competitive as possible, we are also making the following changes:

- Substandard ratings will no longer automatically drop off after 20 years. They will continue as long as the policy remains in force.
- Maximum conversion age is now the lesser of age 70 or 5 years before the end of the level term period (previously the lesser of age 75 or the end of the level term period).

## State Approvals

The new ING TermSmart and ING TermSmart\*NY rates are currently available in all states and jurisdictions except GU, NJ and PR. In these areas, old rates will remain available until the new ones are approved.

### Additional points to note:

- The above rules will apply to informal applications.
- Policies that have been issued before the applicable systems live or transition dates will not be re-issued to get the new rates.
